SANITATION.

The hedgehog enclosures have excess fecal material and soiled bedding present. The licensee stated that they were last cleaned about 2 weeks ago. Excreta must be removed from the animal enclosures as often as necessary to prevent contamination of the animals, minimize disease hazards, and to reduce odors.

The hedgehog enclosures must be cleaned, and a more frequent schedule of cleaning established and maintained.

SANITATION.

The room for the hedgehogs has accumulated fecal material and bedding present on the floor. Clutter, dust and debris are present throughout the room, and cobwebs and debris are present on the walls. Several of the floor tiles are loose and could allow fecal material and pests underneath. Excess equipment and supplies are filling one side of the animal room.

In addition, a large accumulation of animal cages and other equipment awaiting cleaning or disposal are present on the ground in front of the animal building. There is no organization of these materials, and the majority are being kept in unsanitary conditions and could potentially contribute to disease hazards within the facility.

Accumulated bedding and fecal material on the floor and loose flooring tiles contribute to odor and make it difficult to maintain adequate pest control. Excess equipment and clutter make the animal room difficult to clean and sanitize, and accumulated caging and other equipment preclude adequate pest control on the premises.

The floors and walls of the animal housing room must be cleaned, and clutter and debris removed from the room. Loose flooring tiles must be removed or repaired. The licensee must also ensure that all unwanted items are

SANITATION.

Most of the hedgehog enclosures have excess fecal material and soiled bedding present. The licensee stated it has been at least two weeks since the hedgehog enclosures were cleaned. Excreta and soiled bedding must be removed from the animal enclosures as often as necessary to prevent contamination of the animals, minimize disease hazards, and reduce odors. The hedgehog enclosures must be cleaned, and a more frequent schedule of cleaning established and maintained.

3.131(c) REPEAT

SANITATION.

The room for the hedgehogs has accumulated fecal material and bedding present on the floor. Clutter, dust and debris are present throughout the room, and cobwebs and debris are present on the walls. Excess equipment and supplies are filling one side of the animal room.

The licensee has removed some of the animal equipment that was present in front of the hedgehog building; however, many items still remain. There is no organization of these materials, and the majority are being kept in unsanitary conditions and could potentially contribute to disease hazards within the facility.

Accumulated bedding and fecal material on the floor contribute to odor and make it difficult to maintain adequate pest control. Excess equipment and clutter make the animal room difficult to clean and sanitize, and accumulated caging and other equipment preclude adequate pest control on the premises.

The floors and walls of the animal housing room must be cleaned, and clutter and debris removed from the room. The licensee must also ensure that any unwanted items are properly discarded and removed from the property, and that the premises are kept clean in order to minimize odor and pests. Additionally, useful items must be properly
