The U.S. Department of Agriculture has evidence that on or about the date(s) listed below, you or your organization committed violations of the following sections of the Code of Federal Regulations, Title 9:

**Date(s): November 13, 2015, September 15, 2015 and February 11, 2015**

**§ 3.127(b) - Facilities, outdoor.**

*Shelter from inclement weather.* Natural or artificial shelter appropriate to the local climatic conditions for the species concerned shall be provided for all animals kept outdoors to afford them protection and to prevent discomfort to such animals. Individual animals shall be acclimated before they are exposed to the extremes of the individual climate.

**Date(s): November 13, 2015 and February 11, 2015**

**§ 3.127(c) - Facilities, outdoor.**

*Drainage.* A suitable method shall be provided to rapidly eliminate excess water. The method of drainage shall comply with applicable Federal, State, and local laws and regulations relating to pollution control or the protection of the environment.

**Date(s): November 12, 2015 (DIRECT)**

**§ 2.40 - Attending veterinarian and adequate veterinary care (dealers and exhibitors). (DIRECT)**

Each dealer or exhibitor shall establish and maintain programs of adequate veterinary care that include: the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care.
