A 13-year-old female rhesus macaque sustained a hindlimb fracture during a routine cage transfer on 4/23/2023. During the transfer, the nonhuman primate (NHP) escaped from her cage into the room. The animal went behind some of the cages and then started jumping on them, which led to attempted fighting between her and the other NHPs inside the cages. It is unclear exactly how the injuries occurred, but the facility staff observed blood on the macaque's leg and sudden onset of left hindlimb lameness. It is suspected that the animal's leg slipped between the bars of one of the cages and became caught while leaping from cage to cage. Upon examination and fluoroscopic imaging, the NHP was diagnosed with fractures to her left tibia and fibula. In addition, four puncture wounds were noted on the skin overlying the fracture site, which were presumed to be due to fracture segments piercing the skin. The attending veterinarian provided appropriate treatment for the animal, and the fracture is healing well.

Handling of animals shall be done as expeditiously and carefully as possible so as not to cause physical harm.

The research facility implemented corrective actions to include refinements to the animal transfer process, refresher training for staff, and equipment modifications. Corrected prior to the inspection.
