Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The licensee has changed the vaccination and deworming schedule for adults and puppies without consulting their attending veterinarian. The licensee states they no longer vaccinate for Hepatitis and Bordatella in adult dogs or vaccinate puppies at 5 and 7 weeks of age with Neopar and Bronchicine. French bulldog/Pug puppy born 20-May-2023 did not receive the Panacur 3 day course at 7 weeks of age or the Nobivac 1 DAPPV vaccine at 8 weeks of age.

A French Bulldog born 13-December-2022 has not had its initial rabies vaccine at 12 weeks old per the vaccine schedule listed in the Program of Veterinary Care. No appointment has been made at the time of inspection.

The licensee has not communicated with the attending veterinarian about a French/English Bulldog cross puppy (Diamond's litter born 2-July-2023) that has an abnormal eye condition that was noticed at least 2 days prior. A small red growth is located in the interior corner of the left eye and is covering approximately a quarter of the surface of the eye. Failure to follow the Program of Veterinary Care vaccination and deworming schedules approved by the attending veterinarian does not ensure the animals are protected against contagious and/or deadly diseases. Delay in contacting a veterinarian regarding the changing health of the animals does not ensure adequate veterinary care is being provided to diagnose and treat medical conditions.

Each dealer shall use appropriate methods to prevent, control, diagnose, and treat diseases and injuries. The licensee must ensure that all dogs presenting abnormal conditions are evaluated and diagnosed by a veterinarian and that all vaccinations and deworming plans are approved by the attending veterinarian and followed in order to provide the dogs with adequate veterinary care.

2.50(a)(1)

Time and method of identification.

Seven adult dogs do not have official identification placed on the dog. The licensee uses microchips placed under the skin as a form of official identification. The following dogs need a microchip: Gisella, Merlitta, Josie, Maggie, Moxie, Borris and French Bulldog born 13-December-2022. The French Bulldog is still being identified by its puppy cage card. Cage cards are not an acceptable form of official identification for dogs over 16 weeks of age. An acceptable form of official identification (listed below) is necessary for APHIS officials to positively identify animals for inspection and to properly trace their movements.

All live dogs over the age of 16 weeks shall be identified by an official tag affixed to a collar around the animal's neck, by a legible tattoo marking approved by the Administrator, or by a microchip placed under the dog's skin. The licensee must apply one of the forms of identification on the dog and ensure that all dogs have the correct type of official form of

Records: Dealers and exhibitors.

The information for six adult dogs is missing from APHIS form 7005 (Record of Acquisition of Dogs and Cats on Hand). Additionally several dogs are missing their official identification number on the 7005 form. The facility is not keeping record of disposition for dogs donated or rehomed at all. This information is required to be recorded on the APHIS Form 7006 (Record of Disposition of Dogs and Cats). The dogs are crossed off the APHIS 7005 form without a date of sold, removed, death or euthanized. Failure to document the information required on APHIS form 7005 and 7006 may interfere with the ability of APHIS officials to identify animals and to trace their movements.

Each dealer shall make, keep, and maintain records or forms which fully and correctly disclose the required information concerning each dog or cat purchased or otherwise acquired, owned, held, or otherwise in his or her possession or under his or her control, or which is transported, euthanized, sold, or otherwise disposed of. The licensee must add the information for the six dogs to APHIS form 7005 and ensure that all required documents are complete and contain all the necessary information at all times. The licensee must also maintain disposition records that contain all the necessary information for any dog that is sold, removed, donated, died or euthanized on an APHIS form 7006.

Compatible grouping.

One puppy, Pug DOB 20-May-2023, is housed with a dog over 4 months old, French Bulldog DOB 13-December-2022, that is not it's dam or foster dam. Housing puppies with adult dogs that are not their dam or foster dam may result in injuries due to compatibility problems.

Puppies under 4 months of age or less may not be housed in the same primary enclosure with adult dogs other than their dams or foster dams. The puppies mentioned above must be either housed with other puppies under 4 months of age or less or their dam or foster dam.

3.13(b)(3) Repeat

Veterinary care for dogs.

The facility is missing dates of administrations of vaccines and deworming treatments. Two litters of puppies containing a total of 9 puppies did not have dates written down for their 2, 4 and 5 week preventative deworming treatments. Male French Bulldog "Borris" is missing dates and names of medications given after a positive fecal test on 25-March-2023. The dates of adult dog's Parvovirus and Distemper vaccines is also not recorded. Written medical records are necessary for APHIS officials to determine that the animals are receiving adequate veterinary care.

Dealers must keep medical records for dogs that include the names of all vaccines and treatments administered and the dates of administration. The licensee must ensure that all vaccinations and deworming treatments provided to adult dogs and puppies are documented in writing and available for APHIS inspection.

Attending veterinarian and adequate veterinary care (dealers and exhibitors).

Male French bulldog ("Buzz", microchip # 900085000738639) has injuries received in a fight with another dog. The dog's right hind foot is swollen and feels hot to the touch. The medial aspect of this foot was damaged in the fight and a large section of hair, skin and underlying tissues is missing. This affected area starts at the top of the inside toe, wraps around the side of the foot and covers approximately one-third of the bottom of the foot. Therefore, part of the large paw pad has been torn off and blood is coating the hair on the bottom of the foot. The remaining skin on the top of the inside toe is hairless and appears moderately reddened and swollen. A smaller injury was also identified near the toenail of the outside toe. This injured area is moderately reddened and swollen. A reddened, hairless lesion is running across the top of the middle toes towards the inside toe.

Several large injuries are also located along the left side of the dog's spine. The injured areas of skin are hairless and covered in a thick crusty material. A section of skin had been torn from the dog's back and is still attached to one of the affected areas. The hair coat surrounding the wounds is stiff and contains a hard dark colored material.

Female French bulldog ("Lucky", microchip # 900085000739079) has injuries received in a fight with another dog. Two large wounds are located on the outside of the dog's left front leg. The center of the wounds are dark red and fresh blood

is located on the hair surrounding these injuries. A dark, scab-like material is located around the edges of both wounds.

A small abrasion is located on the bottom of the outside toe on the left front foot and a small amount of fresh blood was

found on the surface of this abrasion. Numerous small puncture wounds were also identified along the outside of the right

hind leg and fresh blood is located around many of these wounds. Areas of skin on the inside and outside of the right

hind leg are hairless and slightly reddened with many small red lesions located throughout. The outside of the left hind

leg also has several areas of hairless, reddened skin with numerous small wounds located throughout. Fresh blood is

also present around the wounds on the skin. The inspector was unable to conduct a physical palpation of the hind legs as

the dog appeared to be painful and withdrew the legs each time the inspector attempted to touch them.

The licensee stated that the two dogs got into a fight with each other approximately 3 weeks ago. The licensee had

provided the dogs with an antibiotic but has not consulted with a veterinarian about the injuries the dogs have sustained

and has not provided a treatment plan that has been approved by a veterinarian. Injuries received in fights could cause

pain and discomfort as well as lead to further health issues which could be detrimental to the dog's health and well-being.

Each dealer must use appropriate methods to prevent, control, diagnose, and treat diseases and injuries. The above-

mentioned dogs must be evaluated by a veterinarian for an accurate diagnosis and to develop an effective treatment plan.

The licensee must ensure that each animal receives adequate veterinary care at all times.

Damaged plastic surfaces cannot be properly cleaned and sanitized which could increase the risk of disease hazards.

All surfaces must be maintained on a regular basis. Surfaces of housing facilities - including houses, dens, and other furniture-type fixtures and objects within the facility - that cannot be readily cleaned and sanitized, must be replaced when worn or soiled. The licensee must replace the damaged plastic feeders or alter them in a manner that allows for proper cleaning and sanitization of the surfaces. The licensee must ensure that all surfaces are properly maintained at all times.

Primary enclosures.

One enclosure, containing one adult dog and 4 puppies, has a heat lamp hanging from the top of the enclosure. The heat lamp has no protective guard, and it is hanging low enough that the adult dog could come into contact with the glass bulb. Direct contact with light bulbs could cause burns, as well as additional injuries if the glass should break.

Primary enclosures must protect the dogs from injury. The licensee must add a protective guard to the heat lamp or alter it in a manner that eliminates the ability of the adult dog to come into direct contact with the glass bulb. The licensee must ensure that the enclosures are safe for the animals at all times.

One enclosure, housing one adult dog and one puppy, contains a piece of carpet square. The carpet has been

excessively damaged and shredded into numerous clumps of long tangled strings. The adult dog was observed with a

clump of knotted carpet strings attached to her front foot. The shredded carpet cannot be properly cleaned and sanitized

which could increase the risk of disease hazards. The strings from the carpet can also pose an injury risk to the dogs

should they become entangled or swallow the strings. The facility representative removed the carpet square at the time

of the inspection.

The adult dogs are provided with rubber mats on the floor of their enclosures. At least three rubber mats have been

chewed and damaged by the dogs and small pieces of rubber matting was seen lying on the floor of the enclosures.

Damaged rubber mats cannot be properly cleaned and sanitized which could increase the risk of disease hazards. The

rubber matting may also pose an injury risk should the dogs ingest the rubber.

All surfaces must be maintained on a regular basis. Surfaces of housing facilities - including houses, dens, and other

furniture-type fixtures and objects within the facility - that cannot be readily cleaned and sanitized, must be replaced when

worn or soiled. The licensee must replace the damaged plastic feeders and rubber matting or alter them in a manner that

allows for proper cleaning and sanitization of the surfaces. The licensee must ensure that all surfaces are properly

maintained at all times.

The trash receptacle inside the housing facility has no lid. The receptacle is completely full and a large sack of trash is

protruding above the rim. Trash receptacles without lids could create odors and attract pests such as flies and mice.

Trash containers in housing facilities and in food storage and food preparation areas must be leakproof and must have

tightly fitted lids on them at all times. The licensee must add a tightly fitted lid to the trash receptacle and ensure the lid

remains in place at all times.

A large number of dead flies are located along the counter top around the sink in the housing facility. Dead flies are also

floating in water contained in bowls which are stacked in the sink and dead flies are on the shelf above the sink and

hanging from spider webs beneath the shelf. The accumulation of dead flies could increase the risk of disease hazards

towards the dogs.

Housing facility operators must provide for regular and frequent collection, removal, and disposal of animal and food

wastes, bedding, debris, garbage, water, other fluids and wastes, and dead animals. The licensee must remove all the

dead flies from within the housing facility to support the health of the dogs. The licensee must ensure that the housing

facility remains free of an accumulation of debris and waste, including dead flies, at all times.

The dogs can move between their indoor and outdoor enclosures through a plastic access door. At least two of these doors have areas of a thick dark colored organic material located on their surface. A total of three adult dogs are housed in the enclosures with the affected doors.

A thick buildup of brown organic material, food debris, and hair is located on the interior of one plastic feeder. Two dogs have access to this feeder.

The facility representative believes the surfaces of the enclosures are sanitized at least once a month but may be done more often than that. A buildup of organic material and food waste on enclosure surfaces may increase the risk of disease hazards towards the dogs.

Used primary enclosures and food and water receptacles for dogs must be sanitized at least once every 2 weeks, and more often if necessary to prevent an accumulation of dirt, debris, food waste, excreta, and other disease hazards. The licensee must clean and sanitize the affected access doors and feeder. The licensee must ensure that all surfaces of enclosures are maintained in a clean and sanitized condition to support the health of the animals.

A large number of flies are located within the outdoor portion of the sheltered housing facility. The outdoor dog runs are enclosed by walls and livestock are housed directly outside of these walls. Wet hay, debris, mud, and manure is being pushed beneath the walls and into the walkway in front of the dog runs. A large pool of dark colored water is also located

at the end of the walkway and a bucket of dog manure is sitting in the walkway. The flies were concentrated around the manure bucket, along the walls, and swarming across the pool of water and on the mixture of wet hay, debris, and manure. The inspector observed flies on the fencing of the dog enclosures and on the food receptacles. Approximately twenty-six adult dogs have access to these outdoor dog runs.

Failure to control pests such as flies could cause discomfort to the dogs as well as increase the risk of disease hazards.

An effective program for the control of insects, external parasites affecting dogs, and birds and mammals that are pests, must be established and maintained. The licensee must establish an effective plan to control the large number of flies located in the outdoor portion of the housing facility in order to support the health and well-being of the dogs.

The official identification number is necessary for APHIS officials to trace the movements of dogs, as well as to complete required documents such APHIS form 7005 and medical records.

Each dealer shall make, keep, and maintain records or forms which include the official identification number for each dog.

The facility must add the microchip number to the acquisition information for each of the dogs.

Records: Dealers and exhibitors.

The facility is not using APHIS form 7005 to document the required acquisition information for the dogs. The facility is using APHIS form 7019 instead, which is used to document acquisition information for animals other than dogs and cats. Failure to use the proper APHIS form may result in insufficient acquisition information documented for the dogs.

prevent contamination and spoilage. The facility must have the open bag of food placed in a leak-proof container with a tightly fitted lid in order to protect it from contamination, molding or caking.

Housing facilities, general.

One trash can located inside the kennel does not have a lid. Trash containers without lids could attract pests such as mice or flies which could have a negative impact on the health and well-being of the dogs.

Trash containers in housing facilities must be leak-proof containers and have tightly fitted lids. The facility must have a tightly fitted lid applied to the trash container or remove the trash container from the kennel in order to protect the health and well-being of the dogs.

Veterinary care for dogs.
