This included around his neck, down his back and around his legs. Matted hair can result in skin problems, can be painful, and can compromise the hair's ability to provide protection from the heat or cold. The licensee must remove the matted hair from Philippe and must establish an effective program of haircoat maintenance.

Dental disease is still present from inspection on April 3, 2024, however, licensee has discussed this with the attending veterinarian and a treatment plan has been put in place.

Attending veterinarian and adequate veterinary care (dealers and exhibitors).

Four adult dogs had untreated dental disease. Andre, an 8-year-old male Toy Poodle, (m/c# 7E10092628) had excessive tarter build up on his incisors and molars. His molars were incased with tarter. His incisors had tartar build up covering almost three quarters of the teeth and his gums were red and swollen. Philippe, a 12-year-old male Toy Poodle, (m/c# 0A01670943) had excessive tarter on the canines and molars. On the right side the molars were completely encased in tarter with what looked like a line of white film buildup along the gumline. The gums were red and swollen. FeFe, a 5-year-old Toy Poodle, (m/c# 933000320275138) had excessive tarter mainly on her canines and molars on both sides but was even more excessive on her right side. The gum line is starting to recede away from the second tooth behind the canine tooth and the rest of the gums are red and swollen. Mary, a 2-year-old Yorkie, (m/c# 7E10243938) had excessive tarter mainly on her molars. However, on her left side the tooth behind the canine the gum line is starting to recede and there is a white crème or film like material building up in between the tooth and the receding gum line. The rest of her gums are red and swollen. Teeth and/or gum problems can be painful, can affect the ability to eat, and can result in tooth loss. The licensee must establish an effective program of dental maintenance. The licensee must contact a veterinarian to have these dental problems diagnosed and treated and must maintain medical records for the inspector to review.

The same four dogs had excessively matted hair all over their bodies. Maily found on their backs, their hind feet/hocks and around their heads. Matted hair can result in skin problems, can be painful, and can compromise the hair's ability to provide protection from the heat or cold. The licensee must remove the matted from these animals and must establish an effective program of haircoat maintenance.

Two adult Dachshunds had untreated dental disease. S'mores (m/c# 933000320380513) had excessive tarter on the incisors and molars. The very back molars were encased in tarter. There was also severe gum recession above the left canine tooth. Nutmeg (m/c# 77E10092640) had excessive tarter on her incisors and molars. Some molars were encased in tarter. The gums were red and swollen and recessed away from the teeth. Teeth and/or gum problems can be painful, can affect the ability to eat, and can result in tooth loss. The licensee must establish an effective program of dental maintenance. The licensee must contact a veterinarian to have these dental problems diagnosed and treated and must maintain medical records for the inspector to review. **TO BE CORRECTED BY NOVEMBER 09, 2023.**

The adult female Dachshund named Nutmeg (m/c# 77E10092640) had excessively matted hair on both ears. Matted hair can result in skin problems, can be painful, and can compromise the hair's ability to provide protection from the heat or cold. The licensee must remove the matted hair from this animal and must establish an effective program of haircoat maintenance. **TO BE CORRECTED BY NOVEMBER 10, 2023.**

Housing facilities, general.

In the whelping building, an enclosure housing 5 weaned puppies and an enclosure housing an adult dog had excessive dirt and grime on the outside of the doggie doors used by the dogs. Dirt and grime can harbor organisms that can affect the health of the dogs. The licensee must ensure that hard surfaces in contact with the dogs are cleaned and sanitized as frequently as necessary to prevent soiling of the dogs and to reduce disease hazards. **TO BE CORRECTED BY NOVEMBER 13, 2023.**

An adult, male Dachshund named "Basil" in the outdoor facility could not use either of his back legs to walk. He was pulling himself across the ground with his front legs while dragging both back legs. The licensee picked the dog up and placed him in a sitting position. He was able to maintain the sitting position but would not attempt to move when verbally encouraged. The licensee was not aware of the dog's condition until the inspector pointed out the problem. Daily observation is necessary to detect injuries and disease in the dogs so that they can receive appropriate veterinary care. The licensee must conduct daily observation of all animals to assess their health and well-being. The licensee must have this dog examined by a veterinarian for diagnosis, must follow the treatment recommendations, and must maintain a written medical record for inspection.

Outdoor housing facilities.

Three enclosures containing a total of 12 dogs had shelters with essentially no bedding. One pen with 3 dogs had 4 shelters; a second pen with 4 dogs had 4 shelters; and a third pen with 5 dogs had 4 shelters. The shelters contained varying amounts of gravel inside and a very small amount, if any, of straw for bedding. The ambient temperature during the inspection was 33.9 degrees F. Inadequate bedding can result in discomfort, stress, and increased incidence of disease. The licensee must ensure that shelters contain clean, dry bedding material when the ambient temperature is below 50 degrees F and must provide additional clean, dry bedding when the ambient temperature is 35 degrees F or lower.

Cleaning, sanitization, housekeeping, and pest control.

A large amount of mouse feces was present on a wash-down in the whelping building, including on a lid of a feed receptacle. The inspector observed a live mouse inside the whelping building during the inspection. Mice can contaminate feed and transmit diseases that affect dogs. The licensee must establish an effective program for the control of pests to promote the health and well-being of the dogs.

Adequate clean, dry bedding is necessary to protect the dogs so that they are not in discomfort or at risk for temperature-related health problems. The licensee must ensure that each dog has access to a shelter with bedding when the ambient temperature falls below 50 degrees and must provide additional bedding when the temperature is 35 degrees F or lower.

The inside of the upper cheek was roughened in the area that covered the right canine tooth. The dog was reluctant to allow his mouth to be touched. Teeth and gum problems can be painful, can affect the animal's ability to eat, and can result in tooth loss. The licensee must have this dog examined by a veterinarian and must establish an effective program of dental maintenance.

***An adult female Dachshund (m/c# 481 050 5F5D) was occasionally holding her left front foot off of the ground when standing. Upon examination, there were no visible signs of a problem; however, the dog winced and jerked its left front paw away in pain when the paw was touched. Lameness problems can be painful and can progress if not treated. The licensee must have this dog examined by a veterinarian for diagnosis and treatment.

The licensee must establish and maintain an effective pest control program.
