Re: Request for Immediate Investigation of Apparent Animal Welfare Act Violations by Sally Powell, dba Honey Hill Farm (License No. 61-C-0170)

Dear Dr. Mullaney:

I am writing on behalf of PETA to request that the U.S. Department of Agriculture urgently investigate Sally Powell, dba Honey Hill Farm (License No. 61-C-0170) for apparent violations of the Animal Welfare Act (AWA).

According to multiple videos posted to social media, two adult camels exhibited by Honey Hill Farm escaped their enclosure at Cedar Point Amusement Park on or about June 11. In a video posted to Facebook, the camels are seen running through a crowd of people, including elderly individuals and young children. (*See* Video 1.) The camels were unrestrained and there was clearly no staff member present to protect the public or the camels from harm. In another video posted to <u>TikTok</u>, one of the camels comes within inches of severely injuring a member of the public, while bucking and kicking, undoubtedly due to stress. (*See* Video 2.) Camels are large, dangerous animals that require special care in order to protect the public. Camels can be unpredictable, and have seriously injured and even trampled humans to death, and have sometimes been killed as a result.¹

It appears that Powell is exhibiting these camels in a manner that violates 9 C.F.R. § 2.131(c)(1), which requires that "[d]uring public exhibition, any animal must be handled so there is minimal risk of harm to the animal and to the public, with sufficient distance and/or barriers between the animal and the general viewing public so as to assure the safety of animals and the public."

Powell appears to have further violated the AWA by failing to secure the camels in accordance with 9 C.F.R. § 3.135(a), putting them at risk of severe injury. Moreover, 9 C.F.R. § 2.131(a) and (b) require that persons who maintain wild and exotic animals "must demonstrate adequate experience and knowledge of the species they maintain" and that "[h]andling of all animals shall be done as expeditiously and carefully as possible in a manner that does not cause trauma, ... behavioral stress, physical harm, or unnecessary discomfort."

Please immediately ensure that both camels are thoroughly examined for injuries they may have sustained during their escape. Please also ensure that these camels and any other animals exhibited by Powell at Cedar Point Amusement Park are provided with adequate veterinary care, as well as sufficient food, water, shelter, and that they are otherwise handled in accordance with the AWA. Please hold the licensee fully accountable for any and all violations that you discover during your investigation.
