Attending veterinarian and adequate veterinary care (dealers and exhibitors).

At the facility's medical/treatment room, there were several bottles, vials and infusion bags of prescribed and over the counter medications with expired dates on the labels. All medications intended to be used as therapy for regulated animals should have current expiration dates to provide the best possible care. All expired medications and medical products should be properly discarded immediately.

Records: Dealers and exhibitors.

Records for animals at hand containing required information on acquisition, addition and/or disposition of these, were incomplete at the time of inspection. There were no records or information on the recent acquisition of one red kangaroo. Also, records with information on the disposition of a tufted capuchin and a red kangaroo were not available for inspection. The licensee shall make, keep, and maintain records or forms which fully and correctly disclose information on purchased or otherwise acquired animals, and that are in his or her possession/control. The Record of Animals on Hand (APHIS Form 7019; other than dogs and cats) and Record of Acquisition, Disposition, or Transport of Animals (APHIS Form 7020) are forms which may be used by the licensee to keep and maintain the information required by federal regulations. The licensee needs to obtain/document the required information on all recently acquired animals as soon as possible.

Handling of animals.

On January 20, 2024, approximately at 12:16pm, during a scheduled interaction session a tufted capuchin called "Romeo" scratched two young members of the public; scratches to a index finger, and a hand respectively. Handling of an animal shall be done as expeditiously and carefully as possible in a manner that does not cause trauma/injury to the public or the animal. The facility must ensure handling of animals is performed by seasoned and experienced

3.78(d)

Outdoor housing facilities.

The perimeter fence next to the chimpanzee's main enclosure was observed to be only 27 inches from the enclosure's easternmost wall. The facility's perimeter must be of sufficient distance from the outside wall or fence of the primary enclosure to prevent physical contact between animals inside the enclosure and outside the perimeter fence. The facility must adjust the distance to more than 3 feet; perimeter fences less than 3 feet in distance from the primary enclosure must be approved by the Administrator.

Primary enclosures.

Several welded wire gaps containing sharp points were observed at the Colobus monkey's main enclosure. Housing facilities for nonhuman primates (NHP's) must be kept in good repair, and they must protect the animals from injury and contain the animals securely. Primary enclosures for all NHP's at the facility must be free of jagged edges or sharp points that might injure the animals. The damaged welded wire/gaps must be repaired/replaced to prevent injuries and/or escape, and to ensure the enclosure is structurally sound.

Environment enhancement to promote psychological well-being.

The facility's environment enhancement plan to promote the psychological well-being of nonhuman primates was inspected and found to be incomplete and outdated; the Colobus monkey and squirrel monkey species were not included and/or mentioned in the written plan; environmental enrichment in enclosures was deficient. Facilities must maintain an appropriate plan for environment enhancement adequate to promote the psychological well-being of all nonhuman primate species in the premises. The plan must be in accordance with the currently accepted professional standards as cited in this section of the Animal Welfare Act; appropriate professional journals or reference guides, and as directed by the attending veterinarian. In order to ensure adequate overall welfare for all nonhuman primate species, the plan must be reviewed, updated and approved by the facility's attending veterinarian.

Evidence of a cockroach infestation was identified in the main facility's food prep/kitchen area. Many cockroach droppings (feces) were deposited in top of plastic food containers where nonhuman primate (monkey) biscuits were being stored. Also, an excessive amount of flies were in direct contact with food been prepared, knives. utensils and surfaces. Furthermore, the kitchen doors were completely open to outside areas, and non-functional old fly traps were observed. In order to to prevent food contamination, promote the health and well-being of all nonhuman primates, a safe and effective program for the control of insects, and other pests must be established and maintained.

3.125(a)

Facilities, general.

The African crested porcupine main enclosure exhibited several large dug holes at the concrete base/welded wire junction. Also, in the jaguar enclosure by the medical clinic, protruding construction screws were observed on several resting/walking wood planks posing a potential injury hazard for the animals. . Furthermore, in the jaguar enclosure by the stork's enclosure, excessive rust and damaged metal sliding doors were observed having several sharp metal and in need of repair. Housing facilities for all regulated animals shall be structurally sound and shall be maintained in good repair to protect the animals from injury while containing the animals. To prevent potential injury and to safely contain the regulated animals, all three enclosures must be repaired by removing potential injury hazards immediately.

Facilities, outdoor.

The red kangaroo's primary enclosure was observed to be attached to the main perimeter fence of the facility. The facility's perimeter fence must be of sufficient distance from the outside of the primary enclosure to prevent physical contact between animals inside the enclosure and animals or persons outside the perimeter fence. The facility must separate the kangaroo's main enclosure from the perimeter fence by establishing another panel/side to the main enclosure, with a minimum distance of 3 feet (from the perimeter fence).

The facility must develop a plan as required by the AWA, and ensure the plan is available for inspection upon request by APHIS personnel.
