In a minute, I'll tell you about our staff member Thomas' great birthday ideas and introduce you to Dave and some other dogs who are grateful for your support, but first let me fill you in on where we are with fieldwork.

As temperatures start to cool, we're still working tirelessly to help the countless dogs who are forced to live outdoors 24/7 and who have just endured a burning-hot summer that many others didn't survive. These desperately lonely dogs are often deprived of even the bare necessities, like food, water, and vital veterinary care. They're forced to spend their lives in solitary confinement, chained in backyards without any companionship, play, or affection, suffering from

fly-bitten ears and flea- and tick-covered bodies, doomed to watch the world go by.

Many chained dogs are at risk of freezing to death during cold snaps. That's why all winter long, PETA staffers and volunteers deliver dry, fluffy straw bedding and sturdy wooden doghouses to these "backyard dogs," who are forced to spend their lives outside on a patch of dirt covered with their own waste. The houses we provide are insulated with thick rubber flooring to offer these dogs a little more protection from extreme cold, and unfortunately, there is no shortage of dogs who need them.

All dogs deserve to live indoors with families who love them. Unfortunately, many people in areas where PETA works find that idea absurd and are uncomfortable with the very notion of allowing

dogs inside. This means that many of them can't be persuaded to do the right thing—and in many places the law allows dogs to be chained around the clock. Even in seemingly open-and-shut instances of cruelty, such as starvation cases, we struggle to get enforcement of the few laws that exist to protect these vulnerable canines. That's why PETA also pushes hard for elected officials to pass ordinances that ban or restrict tethering. And town by town, we are slowly succeeding.

But when dogs don't have these protections, PETA fieldworkers and volunteers do everything they can to improve their lives while educating their owners. Although no doghouse is a substitute for a warm, comfortable home with a loving family, the ones we provide make a world of difference to dogs who once had no way to escape the scorching sun or bitterly cold winter storms.

Sometimes we're able to persuade owners to give






up "outside dogs." For example, in January we secured the relinquishment of Stella—a severely emaciated dog who had always been left outside, even on the coldest days of the year. Safe and warm at our headquarters, she spent the night on a comfy couch before moving on to a local shelter, where she was quickly adopted.

Early this year, we found a tiny gray-and-white puppy in a crate on a porch outside in the elements. He wouldn't have survived much longer in the biting cold, but we had him surrendered into our care and warmed him up before passing him on to a trusted local shelter, where he was adopted. Rescues like these are only possible thanks to your steady support.

Together, we can give more dogs like these a chance at a better life. They would thank you if they could for supporting PETA's work in behalf of dogs like them!





From Despair to Devotion:

How Dave Became Roux

When PETA fieldworkers found Dave, he was an underweight puppy suffering from mange and covered with fleas. Despite his obvious suffering, the owners refused to seek veterinary care or turn him over to us. Instead, they hid him when we called law enforcement, and he remained missing during fieldworkers' subsequent attempts to check on him.

One week later, we found Dave back in the same location and in even worse shape—but this time, law-enforcement officers responded while our fieldworkers remained rooted to the spot and took legal custody of him.

The officers allowed PETA to take Dave for emergency care on their behalf, and the veterinarian said the dog was suffering from the worst flea infestation he'd ever seen. Dave also tested positive for internal parasites, flea anemia, and demodectic mange. The rescued pup recovered at the local municipal shelter until he could be transferred to our shelter and neutered on one of our mobile clinics.

Thanks to PETA's local shelter partner Reba's Rescue, a loving family adopted Dave—now named Roux—and is determined to write a happy ending to his story. He spends his days playing with toys and snuggling with his family. His shiny black coat shows no signs of the trauma he endured.



Vegan Maple Pumpkin Pie Makes 16 to 20 servings.

Ingredients

- 2 9-inch vegan pie crusts
- 1 cup soft or silken tofu, puréed
- 3 Tbsp. arrowroot powder
- 2 Tbsp. cornstarch
- 2 tsp. cinnamon
- 1/2 tsp. ground nutmeg
- 1/2 tsp. ground ginger
- 4 Tbsp. flour
- 1 cup maple syrup
- 1/2 cup sugar (or less)
- 3 1/2 cups pumpkin purée
- · 2 cups coconut cream

Note: Bake the pie the day before you're going to eat it (or at least early in the morning for dinner that night). It needs time to set in the fridge before slicing.

Instructions

- 1. Preheat the oven to 350°F. Parbake the pie crusts for about 10 minutes, then remove from the oven and allow to cool.
- 2. Place the puréed tofu in a large bowl and gradually mix in the arrowroot, cornstarch, cinnamon, nutmeg, ginger, and flour. Whisk until well combined, then add the maple syrup and sugar.
- 3. In a small saucepan, mix the pumpkin purée and the coconut cream over medium-high heat for about 5 minutes, stirring frequently until smooth.
- 4. Pour the hot pumpkin mixture into the bowl with the tofu-spice mixture, stirring as you pour. Mix very well.
- 5. Pour half the filling into each pie crust and bake for 45 to 50 minutes, or until the pies are golden brown and puffed up around the edges.
- 6. Remove the pies from the oven and let cool for 1 hour. Then cover each pie with plastic wrap and refrigerate to set, ideally for at least a day.

- If you're age 70.5 or older, you may be able to make a qualified charitable distribution of up to \$53,000 from your IRA to fund a gift annuity.

Setting up a charitable gift annuity with IRA funds allows you to make a significant donation while receiving a fixed, steady income for life. This method makes an impact for PETA far into the future while you receive immediate benefits today!
