### Attending veterinarian and adequate veterinary care (dealers and exhibitors).

Male dachshund #021 (Atlas) has not had his dental cleaning scheduled as guided by the attending veterinarian (AV) in the March 2024 physical exam. His teeth were observed to be covered by plaque/tartar and one of his upper left teeth was slightly loose when touched. Dental problems left untreated can cause dogs to be unhealthy and cause discomfort. Ensure to contact the AV and have this dog's teeth evaluated and treated per the AV's instruction.

Two medications that have been used on dogs/puppies this summer per the licensee were expired: Ivermectin pour-on (Exp 3-2024) and Metronidazole (Exp 2-2023). Expired medications might not work as intended or could make animals sick. Ensure that expired medications are properly disposed and not used.

A 52-day old puppy (#146) was transported and sold at a swap on 10-28-2024. To protect their health, puppies must be at least 56 days old and weaned prior to transportation in commerce. Ensure that puppies are at least 8 weeks (56 days) old and weaned prior to any transportation in commerce.

### Primary enclosures.

The area where feeders are attached to the gate have metal rails that were cut for the feeder space and have edges that were rough/sharp to the touch. Also, a broken flapper door for two poodles had edges by the hinges that had points. Points and edges could hurt dogs. Ensure surfaces are free from sharp points and edges.
