Outdoor housing facilities.

On the night of November 22nd, 2024, a night husbandry team member conducting routine evening rounds noted animals down in a field cage. The employee immediately contacted additional personnel who promptly returned to the facility to address the situation. Due to the quick actions of the facility employees, 32 of the 54 impacted cynomolgus monkeys survived the event.

According to the facility, the clinical presentation of the animals, lack of high temperatures or natural gas odors suggested the likely presence of carbon monoxide (CO) gas. Necropsy and histopathology findings on the animals that did not survive were consistent with exposure to CO gas.

The facility conducts routine maintenance checks on all heating units prior to their use, with the most recent mechanical check on the associated unit completed two months prior and passing all safety checkpoints. In addition, the same heating unit was used the night before without incident.

Shelters provided with auxiliary heating that are unable to safely provide warmth can result in adverse health impacts, stress, and extreme discomfort of the nonhuman primates housed therein. The shelter must safely provide heat to the nonhuman primates to prevent the ambient temperature from falling below 45F, except as directed by the attending veterinarian and in accordance with generally accepted professional and husbandry practices. Corrective actions were immediately taken by the facility prior to this inspection.

This inspection and exit interview were conducted with the facility representatives and licensee.
